#### Overview

The NB/PEI Educational Computer Network (ECN), founded in 1970, connects all of the universities, community colleges and the Maritime College of Forest Technology in New Brunswick (NB) and UPEI and Holland College in Prince Edward Island (PEI). The primary service provided by the network is connectivity among its members and to the wider world. Many additional benefits are enjoyed by members, notably joint purchasing and licensing, shared IT services, professional development, cyber security and the delivery of network-based services and information exchange.

This approach has enabled all ECN members to realize the benefits of a high capacity, high speed data communications network at a reasonable cost, regardless of size. It also allows members to take advantage of economies of scale not available to individual member institutions, and ensures that smaller institutions receive the same level of service as larger ones. The ECN reduces overall IT expenditures for its members by an average of \$1.3 million annually, resulting in 100% return on investment. Through economies of scale, and with expertise contributed by all, ECN members pay less for many software applications, connections to commercial internet services, and equipment, than they could independently. Finally, members become stronger on the national front by providing a united voice with respect to the collective needs of New Brunswick and Prince Edward Island research and education sector.

ECN is one of the oldest yet most innovative of the higher education IT consortia across Canada. ECN members benefit from a strong governance and management model, and a reasonably secure budget that ensures continuity and flexibility. ECN's collaborative and collegial culture firmly supports its many accomplishments.

#### More about ECN

Following a pilot project in the late 1960's, the NB Educational Computer Network was formed in 1970 when the New Brunswick Higher Education Commission, Mount Allison University, I'Université de Moncton, the University of New Brunswick, and St. Thomas University entered into an agreement to share computer-processing services. In 1974, the newly formed Maritime Provinces Higher Education Commission (MPHEC) assumed stewardship of the Agreement and in 1975, the University of Prince Edward Island joined as a full member, establishing the NB/PEI ECN. The signing of a five-year agreement, from May 1, 1992 to April 30, 1997, formalized the addition of Holland College as the next member of the group. A subsequent five-year agreement (May 1, 1997 to April 30, 2002) witnessed the addition of the Maritime Forest Ranger School (now the Maritime College of Forest Technology) to the list of member institutions of the ECN. The agreement (January 1, 2017 to March 31, 2022) witnessed the addition of the Collège

communautaire de Nouveau Brunswick (CCNB) and the New Brunswick Community College (NBCC) to the list of member institutions.

The ECN is overseen by a Board of Directors, consisting of the Presidents of the member institutions and the Chief Executive Officer of the MPHEC. The overall management and operation of the network and the associated services is the responsibility of a Network Committee consisting of the Senior IT positions from each member institution. The ECN is funded by the Provinces of New Brunswick and Prince Edward Island, through the funding administered by the MPHEC, and is topped-up with some direct funding from some of the institutions.

In addition to providing connectivity among its members, both NB and PEI portions of the network also connects member institutions to the wider world through a shared connection to the Canadian Advanced Research Network (CANARIE) and through CANARIE to the world. ECN has been highly successful in attracting capital investment from the federal government with over one million dollars contributed to the development and expansion of the NB research and education communications network and the Security Information and Event Management (SIEM) project over the last five years. Inestimable value from collaboration, cooperation, and highly professional relationships among the members has contributed greatly to ECN's reputation across Canada as having one of the best governances, management, and operating models among similar organizations.

#### ECN highlights for 2021-2022 include:

The NB/PEI Educational Computer Network (ECN) continued to successfully provide connectivity among its members and to the wider world, just as it has for the past 52 years.

- With continued COVID-19 restrictions in place, the ECN50RIÉ and AtlanticNet 2020 were delayed for another year and subsequently cancelled. A celebration of the ECN's 50<sup>th</sup> plus will be held in the fall of 2022.
- The Communications Team continued to circulate, promote, provide updates on ECN successes, and keep partner information (NREN and CANARIE) current by using the website as a communication tool.
- A new 5-year ECN Agreement (2022-2027) was signed by Board members in January 2022.
- Several ECN institutions are participating in the CANARIE led and funded Cybersecurity initiative program (CIP). Enhancing security through access to tools, people and processes at no cost.
- Completed the deployment of QRadar Security and Event Management (SIEM) platform
  for the ECN and all ECN member sites. This initiative will improve the consortium security
  with the use of monitoring and alerting tools. A Security Analyst position, partially funded
  by CANARIE, was created and filled to analyze the data and provide support to members.

- With the completion of the installation, the development of an RFP, for the management and monitoring services of the QRadar for 24/7 coverage will be finalized.
- The Climate Change Centre installation in Saint Peter's Bay, PEI progressed and will be in operation by June 2022. This installation will provide a failover through the CANARIE link to Moncton.
- The CANARIE Expression of Interest was approved for the business continuity or disaster recovery connections between the primary nodes between Saint John, Fredericton and Moncton on the NB portion of the network. Fredericton has two data centres which will have ISP connection and a CANARIE connection at both centres.
- In November 2021 the technical workshop was held for the second time "virtually". The
  workshop consisted of a series of short sessions and presentations on a variety of topics
  with about 80 people attending. Once again, ECN O365 staff built a platform using
  SharePoint in conjunction with Microsoft Teams to deliver the online sessions
  successfully.
- Staff from UNB (hosting service) and other ECN institutions worked together to set up a VOIP Telephony Shared Service that will enable ECN institutions to connect their individual MS Teams Voice environments. Following testing, the service is set to go live in June 2022. This initiative will provide significant cost savings for the ECN members.

## Governance (Board of Directors)

The ECN is governed by a Board of Directors (Board) consisting of the following members:

- The President of Holland College
- The Executive Director of the Maritime College of Forest Technology
- The Chief Executive Officer of the MPHEC
- The President of Mount Allison University
- The President of St. Thomas University
- Le recteur de l'Université de Moncton
- The President of the University of New Brunswick
- The President of the University of Prince Edward Island
- The President and CEO of the New Brunswick Community College
- Le président-directeur général du Collège communautaire du Nouveau-Brunswick

The Chairperson, whose term is five years, renewable for a second five-year term, is elected by the Board. Quorum is six members. Decisions must have the unanimous consent of those members voting (with the exception of a vote declaring that the service of the designated installation is inadequate; in which case the designated member is ineligible to vote). Generally, two meetings are held each year. The MPHEC performs administrative duties for the Board and manage the budget on behalf of all the members.

#### Network Committee

The NB/PEI Educational Computer Network Committee (Network Committee) includes one voting representative nominated by each of the parties of the Agreement as well as a voting member who represents the Network Operations. An alternate representative to the Network Committee is also appointed. Members and alternates are appointed for an indefinite period or are replaced upon recommendation in writing to the Chairperson of the Board. The Chairperson of the Network Committee is nominated by the Network Committee, and is non-voting, and is approved by the Board for a maximum of two 2-year terms. The MPHEC representative is the Secretary of the Network Committee. The Network Committee meets 5-6 times annually. The duties of the Network Committee are listed in Appendix A of the ECN Agreement. The Network Committee makes decisions by unanimous consent of members voting.

The Network Committee submits, on or before February 15, a recommended Network Plan and Budget to the Vice-President (Finance) of each of the member institutions for confirmation. Once confirmed, the Network Committee submits the Network Plan and Budget to the Board for approval. At the end of the year, the Committee drafts an annual report for approval by the Board showing its performance compared to the Network Plan from the beginning of the fiscal year.

## Designated installation

UNB is the designated, and the major, installation for the Network. Computing facilities and Information and Communication Technology (ICT) services are provided by UNB to all ECN members as detailed in Appendices B and C of the ECN Agreement.

## Strategy

The key shared service of the ECN is connecting member institutions via a high-speed, high-capacity research and education network. Members also jointly purchase and deploy IT products and services such as anti-virus software, Office 365, firewalls, password manager solution and security and event management. being some examples of successful collaborations.

ECN updated its strategic plan to focus on the following areas:

<u>Communication and collaboration tools</u>: ECN continues to expand the use of M365 (Microsoft's software platform used for file sharing and co-editing, document and records management, and collaboration), by launching a project to implement Teams telephony as a service; ultimately, this will significantly reduce telephony costs for participating institutions.

<u>Consortium Security</u>: Security issues continue to be a high priority the ECN. The second phase of the national security incident and event management (SIEM) project is nearing completion; we've extended the SIEM to all individual institutions, and logs are now flowing through the tool for analysis and assessment. Most ECN institutions are participating in the CANARIE-led and funded Cybersecurity Initiatives Program (CIP), which to date has made intrusion detection, benchmarking, and other tools available to all at no cost.

<u>Network sustainability and improvement</u>: ECN has focused on network development, extending it where needed, while building in resiliency and redundancy wherever possible. Expansion of UPEI's network to Saint Peters Bay was begun, and renewal of equipment throughout the network was also started.

A table of strategic objectives is in Appendix III.

## Financial operations

A copy of the approved budget vs actual expenditures for 2021-2022 (showing a deficit of \$415,303 (NB: -\$410,325); (PEI: -\$4,978) as well as the balance of the ECN committed funds as of March 31, 2022 is included in Appendix IV. New Brunswick's deficit was the result of the planned purchase of hardware and licensing for the QRadar application for the SIEM coverage at the ECN member institutions as well as costs related to the preparation of the VOIP telephony project and maintenance of the new firewall build. Internet Access was higher than budgeted on the PEI side but under budget on the NB side. Hardware, software and maintenance were all below budget for the year. The CAF membership remains stable with no increases and SharePoint services

expenses were slightly lower than budget. Due to ongoing COVID restrictions, meetings and training expenditures are nil. Although the Network operation core costs were stable, additional hardware was purchased for upgrading the Network which reflects an increase overall. The NB GigaPOP was as budgeted. In PEI, most budget line items fell in line with what was proposed although Internet Access was higher. The ECN's accumulated surplus of \$598,234 (NB: \$527,567; PE: \$70,667) will be used to fund some of the newer initiatives as well as other Cyber Security initiatives, Network maintenance and Disaster Recovery. A strategic planning session is scheduled in the first quarter of 2022-23 at which time the ECN Committee will be considering how to best leverage, our resources for cost savings moving forward and to determine the budget line items and the use of our committed funds moving forward.




New Brunswick Research and Education Network

NB REN – Research and Education Network with Optical Transport Layer


